1. PENSIONS FOR COUNCILLORS 2. CHANGE TO METHOD OF DISTRIBUTING CIRCULARS

Purpose of this circular

- 1. This Circular
 - seeks information from local authorities on pensions for councillors. Authorities are asked to complete and return the attached councillors' pensions questionnaire by 31 August 2008
 - notifies a change in the method of distributing future LGPC Circulars. Current recipients of the Circulars are asked, by no later than 31 August 2008, to confirm to elaine.english@lge.gov.uk the e-mail address (or maximum of 3 addresses) to which they wish future Circulars to be sent.

Pensions for Councillors

2. Authorities may recall that back in 2004 the LGPC, via Circular 149, sought various information on pensions for councillors (in England) i.e. the recommendation of the Independent Remuneration Panel, the decision taken by the authority, and the take up rate of members offered access to the LGPS. The results of the survey were reported in Circular 155 – see http://www.lge.gov.uk/lge/core/page.do?pageld=119538.

3. Representing the future: The report of the Councillors Commission was published on 10 December 2007 - see http://www.communities.gov.uk/documents/localgovernment/pdf/583990.pdf
Recommendation 58 in the report was that "All councillors should be entitled to access to the local government pension scheme, and any allowances for serving on joint authorities should also be taken into account". In reaching its conclusions the Commission made reference to the survey conducted by the LGPC in 2004. In order to have up to date statistics on pensions for councillors in England, Wales and Scotland, the LGPC would be grateful if authorities could complete and return the attached questionnaire by 31 August 2008. The information provided will be analysed and a statistical breakdown of the responses will be issued to authorities under cover of a subsequent LGPC Circular. This will be a generic report; individual authorities will not be identified in the report.

Change in the method of distributing future LGPC Circulars

4. For many years the LGPC has issued hard copies of LGPC Circulars to authorities and other bodies on our mailing list. However, to improve the speed at which we can deliver Circulars to you and to reduce printing and postage costs, we have decided that future Circulars will be issued electronically via e-mail.
