PENSIONS FOR COUNCILLORS

Purpose of this circular

- 1. In 2004 the LGPC conducted a survey of pension provision for councillors in England (see Circular 149 of February 2004), the results of which were reported in Circular 155 of April 2004.
- 2. In July 2008 the LGPC conducted a further survey, but this time covering the pension provision for councillors in England, Wales and Scotland (see Circular 214). The results of the July 2008 survey are attached at annex 1. We hope this will be of interest to authorities.
