Review of climate risk reporting in the private sector

The Pensions Regulator (TPR) has published a <u>review of climate-related</u>
<u>disclosures by occupational pension schemes</u>. It sets out TPR's preliminary
observations and feedback to industry. This is based on their review of a selection

of climate-related disclosures published by occupational pension schemes. The review relates to private pensions schemes but contains observations which may be useful for LGPS funds ahead of the implementation of Task Force on Climate—Related Financial Disclosures (TCFD) reporting.

Sharia compliance report commissioned

The SAB received <u>legal advice</u> suggesting it should instruct an expert in Islamic finance to provide evidence on a range of issues around sharia compliance in the LGPS. The SAB has commissioned expert advice from Amanah Associates and their report will be due around three months' time.

Changes to the SAB's cost management process

On 11 May 2023, the Department for Levelling Up, Housing and Communities (DLUHC) <u>published its response</u> to the consultation on changes to the SAB's cost management process. See <u>bulletin 233</u> for more information.

Also on 11 May 2023, the Government laid the Local Government Pension Scheme (Amendment) (No.2) Regulations 2023 ('the regulations'). These come into force on the 1 June 2023.

The changes better align the SAB's cost management process with HM Treasury's (HMT's) reformed cost control process. They give the SAB greater flexibility in the making of recommendations to the Secretary of State where there is a breach.

DLUHC's response helpfully re-iterates the SAB process operates before HMT's cost control mechanism. However, it leaves open for further discussion the link with the new "economic check" in HMT's process.

Guarantee for academy trusts outsourcing arrangements

On 17 May 2023, the Department for Education (DfE) published their policy for guaranteeing the outsourcing arrangements of academy trusts. This applies to England only.

Education and Skills Funding Agency (ESFA) approval is no longer required by academy trusts seeking pass-through arrangements with their administering authorities for outsourcing contracts for employees covered by the DfE Guarantee policy. The DfE Guarantee covers employees eligible for the LGPS who:

 are working for the academy trust, who are transferred to a contractor or on future re-tenders as part of an outsourcing contract

- were working for the local authority in a maintained school, then transferred to a contractor under TUPE, prior to the school becoming an academy, and where the outsourcing contract has passed to the academy trust following conversion to an academy
- are working for the local authority, which is providing services to the
 academy trust under a contract, and the trust decides to outsource this
 contract to a third-party provider. Therefore, the employees transfer from the
 local authority to the new contractor.

Key points

- 1. Provided the circumstances of an outsourcing contract match one or more of the scenarios outlined in the policy document the academy trust does not need to seek ESFA approval for pass-through arrangements.
- 2. If the circumstances of an outsourcing contract are not covered in the policy document, the academy trust must seek ESFA approval using the Education and Skills Funding Agency enquiry form.
- 3. All contracting arrangements currently in place that meet the criteria outlined in the policy document are eligible for pass-through under the DfE Guarantee.
- 4. Where academy trusts have already entered arrangements that do not meet the criteria outlined in the policy document, they may discuss alternative options with the relevant administering authority.
- 5. Under a pass-through arrangement, if the contractor external to the academy trust ceases to trade, then the LGPS liabilities will remain with the trust. The trust may then choose to seek a new provider or bring services in-house.
- 6. The policy means the administering authority should no longer require a bond for pension liabilities. However, if they insist, that would be for the external contractor to provide, as an academy trust cannot provide a bond for LGPS pension liabilities. Where this happens, academy trusts should notify ESFA through the Education and Skills Funding Agency enquiry form.

Action for administering authorities

Provided the conditions in the DfE policy document are met, you do not need to request evidence of ESFA approval for pass-through arrangements. Update your processes and notify your academy trusts.

McCloud remedy consultation

On 30 May 2023, <u>DLUHC published a consultation and draft regulations</u> concerning the McCloud remedy. The consultation closes on 30 June 2023.

The consultation seeks views on proposals to address discrimination found by the courts in the McCloud case. This follows the Government's response published in April 2023. See <u>bulletin 237</u> for more information.

DLUHC is consulting on new approaches in certain areas that reflect responses to the 2020 consultation and more closely align the LGPS to policies adopted by other public service pension schemes. DLUHC is seeking views on the following proposals:

- No aggregation requirement: underpin protection will extend to a new pension account that started before 1 April 2022, even if the earlier period of membership is not aggregated, as long as there has not been a disqualifying break.
- Previous membership of another public service pension scheme on or before 31 March 2012: a member will qualify for underpin protection because of earlier membership of another public service pension scheme, even if the pension rights from the other scheme have not been transferred to the LGPS, as long as there has not been a disqualifying break.
- Flexible retirement: a member with underpin protection who takes flexible retirement before 1 April 2022 will also have underpin protection on any benefits built up after flexible retirement and before the end of the underpin period. The consultation also considers how the underpin will operate when a member takes partial flexible retirement.

The consultation covers topics that were not included in the 2020 consultation. These include:

- policies for individuals with excess teacher service see <u>Bulletin 229</u> for background information on this group
- when a member may be paid compensation if they have suffered a loss relating to the discrimination found in the McCloud case or the McCloud remedy
- the interest terms that will apply when payments are made late due to the McCloud discrimination.

We will respond to the consultation in due course and let you know we have done so. You can access the consultation documents on the <u>Scheme consultations</u> page of <u>www.lgpsregs.org</u>.

SCAPE discount rate and impact to actuarial factors - update

In <u>bulletin 236</u> we let you know certain transfer calculations and cash equivalent values for divorce should be immediately suspended following the change to the SCAPE discount rate in March 2023.

On 25 May 2023, we met with DLUHC to discuss the publication of the revised factors. We can confirm we are expecting these imminently.

We will publish the new factors on the <u>Actuarial guidance page</u> of <u>www.lgpsregs.org</u> together with a revised transitional table. We will also email administering authorities to let them know the new factors are available.

SAB February 2023 meeting

On 10 May 2023, the Scottish Scheme Advisory Board (SAB) published the minutes of its meeting held on 8 February 2023.

On 28 April 2023, Iain Coltman sent a letter to administering authorities. The letter sets out SPPA's position on the following three aspects for authorities to consider when undertaking the 2023 triennial valuation:

- McCloud remedy
- cost cap valuation
- Section 13 report recommendations.

DWP

Automatic enrolment - call for evidence

On 15 May 2023, the Department for Work and Pensions (DWP) published a call for evidence on the alternative quality requirement used by defined benefit schemes for automatic enrolment (AE). The call for evidence closes on 19 June 2023.

The existing requirements allow for simpler alternative tests to be used so the scheme can demonstrate it is of sufficient quality to be used by employers to fulfil their AE duty. The call for evidence aims to conclude whether the government's policy in this area continues to be achieved.

Action for administering authorities

Notify your employers of this call for evidence.

HMRC

Consultation on second set of rectification regulations

On 22 May 2023, HMRC launched a consultation on The Public Service Pension Schemes (Rectification of Unlawful Discrimination) (Tax) (No.2) Regulations 2023.

The draft regulations supplement <u>The Public Service Pension Schemes</u> (<u>Rectification of Unlawful Discrimination</u>) (<u>Tax</u>) <u>Regulations 2023</u> ('first set of regulations'), which came into force on 6 April 2023.

The first set of regulations modifies various tax legislation, so the correct tax treatment is applied when public service schemes implement the McCloud remedy. For more information, see the commentary we provided on these. The draft regulations propose further modifications.

HMRC will shortly publish guidance on the draft regulations.

As part of the consultation, HMRC will hold several round tables. These will provide an opportunity to raise any technical points on the draft regulations. The consultation closes on 19 June 2023.

Remedy newsletter – May 2023

On 23 May 2023, HMRC published <u>Remedy newsletter May 2023</u>. The newsletter provides information on the following topics:

- Draft regulations: summarises the draft rectification regulations mentioned in the previous article.
- HMRC processes: HMRC is developing processes it will need to support the McCloud remedy. As part of this, they will provide a single point of contact for each public service organisation. The newsletter also asks for details of a named contact within each organisation to set up initial meetings to help

- develop the processes. We have contacted HMRC to clarify if the named contact is at a local or national level.
- Guidance: HMRC is drafting McCloud remedy guidance, which they hope to
 publish in Autumn 2023. In advance of this, they would like to test some of
 the guidance with users to make sure it is covering what is needed. If you

HMT

Public Service Pensions – cost control mechanism and reformed scheme only design

On 15 May 2023, HM Treasury (HMT) published a <u>written ministerial statement</u> and <u>further detail</u>, on the cost control mechanism and reformed scheme only design.

The publications confirm only the reformed scheme design will be included in the cost control mechanism. Any cost increases associated with final salary benefits and the impact of the underpin will be excluded.

Pensions dashboards ('dashboards')

Consent and authorisation wording for dashboards

The Pensions Dashboards Programme (PDP) commissioned Ipsos to undertake research to help develop consent and authorisation wording for dashboards.

A research group covering a range of ages, income levels and pension types was asked to provide feedback on draft versions of consent and authorisation wording that would appear on dashboards. The wording explained what the Money and Pensions Service would and would not do with users' data and asked for consent for these uses. The feedback was positive and will be used to further shape the wording.

Latest news

In May 2023, PDP <u>published their Progress update report on dashboards</u>. There are articles on:

- the Department for Work & Pensions (DWP's) written ministerial statement on pensions dashboards connection times confirming that there will be an update before parliamentary recess in July
- programme reset following the written ministerial statement reset got underway on 20 March and more information will be available before parliamentary recess in July

- preparing for dashboards connection, data, matching, awareness and understanding legal and regulatory obligations

Pensions Dashboards (Prohibition of Indemnification) Act 2023

On 2 May 2023, the <u>Pensions Dashboards (Prohibition of Indemnification) Act 2023</u> received Royal Assent.

The Act will prohibit trustees and managers of occupational and personal pension schemes from being reimbursed out of scheme assets for any penalties imposed on them under the dashboard regulations.

The Act applies to the United Kingdom and comes into force on a date determined by the Department for Work and Pensions (or, in the case of Northern Ireland, the Department for Communities).

TPO

'Where to go for help with your pension complaint' factsheet

On 27 April 2023, The Pensions Ombudsman (TPO) published a factsheet titled 'Where to go for help with your pension complaint'.

The factsheet helps members to decide if to refer their complaint to TPO or the Financial Ombudsman Service.

TPR

Blog on refreshed guidance for trustees in challenging times

On 10 May 2023, <u>TPR published a blog</u> on refreshed guidance for trustees in challenging times.

TPR have refreshed their guidance to support trustees dealing with employer stress or distress during economic challenges. They urge trustees to revisit this guidance, and, where appropriate, take action and engage with TPR at an early stage.

Blog on why ignoring ESG is no longer an option

On 17 May 2023, <u>the Pensions Regulator (TPR) published a blog</u> on why ignoring environmental, social and governance (ESG) factors is no longer an option for trustees.

The blog discusses developments in government policy, increased regulations, industry initiatives and greater industry awareness of the implications for life.

Capita cyber security incident

On 12 May 2023, the Pensions Regulator (TPR) updated its website with a page covering the Capita cyber security incident. This follows a security breach where it is now known that some data has been exfiltrated from Capita's servers.

TPR encourages all administrators who use Capita's services to check whether their pension scheme data could be affected.

Other news and updates

Club transfers – extending the 12-month time limit

On 26 April 2023, the Cabinet Office clarified a Club transfer may take place outside the 12 month time limit, in exceptional circumstances and providing both the sending and receiving schemes agree. Colin Hennem (Pensions Technical Manager) confirmed:

"the Club Memorandum requires a transfer to be calculated on Club terms if the member confirms in writing that they wish the transfer to proceed within 12 months of joining the new Club scheme. The Club Memorandum is silent on what should happen if that confirmation is sent outside the 12 month lime limit. However, it has long been our policy that the two schemes involved may agree to a Club transfer outside the 12 month time limit (ie a belated Club transfer) if there are exceptional circumstances that prevented the member from sending the confirmation within the 12 month time limit - eg if there were delays in providing the necessary quotes that were outside the member's control. In the past, when the additional cost of the more generous Club transfer terms was met by the receiving scheme, our view was that it

was only necessary for the receiving scheme to agree to a belated Club transfer. However, under the 'inner' Club arrangements, the additional cost of the more generous terms is spread more evenly between the two schemes. Therefore, I think it is appropriate that a belated Club transfer can only proceed if both the sending and receiving schemes agree to this. The Cabinet Office (as Secretary to the Club) has no authority to compel the schemes in question to agree to a belated Club transfer."

Action for administering authorities

Incorporate this clarification into your Club transfer process.

Club transfers – new factors and revised memorandum

On 16 May 2023, Cabinet office let us know they plan to issue new Club factors and a revised memorandum. It is intended these will come into force on 1 October 2023.

The new factors take account of the change to the superannuation contributions adjusted for past experience (SCAPE) discount rate made in March 2023.

The revised memorandum will contain instructions for members affected by McCloud and have minimal impact on members not affected by McCloud.

The new factors and revised memorandum will be shared before 1 October 2023 to allow administering authorities to prepare before they come into force.

Your LGPS contacts - May 2023 elections

Administering authorities are responsible for updating their own contacts using the 'Your LGPS contacts' system. Following the May 2023 elections, we have received a high volume of undeliverable messages to political contacts. We also have a high level of undelivered messages to finance contacts.

Fundamentals training 2023

Our Fundamentals training for 2023 is now open for booking.

Fundamentals is a three-day training course predominately aimed at elected members and others who attend pension committees and local pension boards. Past delegates have also included trade union and employer representatives, and officers who support committees and boards. The course provides a scheme overview and covers current issues in relation to administration, investments and governance of the LGPS. All sessions are delivered by experts in their field. We are running the in person training in two locations - London and Manchester, and online.

Annual revaluation date change

On 17 May 2023, the Department for Communities made the Local Government Pension Scheme (Amendment) Regulations (Northern Ireland) 2023. The regulations change the annual revaluation date in the LGPS in Northern Ireland. The regulations came into force on 12 June 2023, with backdated effect to 1 April 2023.

The regulations make similar changes to those made to the LGPS in England and Wales. See <u>bulletin 234A</u> for more information.

NHS Pension Scheme consultation: changes to contribution thresholds

On 3 May 2023, the Department of Health and Social Care launched a consultation about uplifting member contribution thresholds in the NHS Pension Scheme 2015 (England and Wales) for 2023/24. The consultation closed on 17 May 2023.

On 25 May 2023, the Department responded to the consultation, confirming they will proceed with the changes.
