## **Coming Soon! New Frameworks for 2024**

#### National LGPS Framework for Integrated Service Providers (ISP) and Member Data Services.

To support Funds with the upcoming requirements of Pensions Dashboards we have been working with Cheshire, Essex, Greater Manchester, Merseyside, Norfolk, West Midlands and West Yorkshire Pension Funds along with NILGOSC to establish this new Framework.

This Framework will provide the LGPS with a compliant route to market for an ISP, as well as support with data quality and dashboard readiness. An ISP offers a scheme administrator connectivity to the Pensions Dashboard Ecosystem. The Framework will also offer services including address tracing and correction services, mortality screening, overseas address tracing and correction, overseas proof of life and mortality screening, bank account verification and data quality reporting.

The tender documents for this Framework have been issued and we plan to launch the Framework in early April 2024.

#### National LGPS Framework for Additional Voluntary Contribution Services (AVC)

The first National LGPS Framework for AVC Services is currently being worked on with support from Cheshire, Dumfries and Galloway, Leicestershire and Strathclyde Pension Funds. This Framework is being developed to support Funds in meeting their AVC responsibilities and will have 2 Lots: for Additional Voluntary Contribution Services; and for AVC Consultancy Services.

This Framework is scheduled to go-live at the end of April 2024.

## New Frameworks planned for 2024/25

We always try to ensure that we have available to the LGPS the Frameworks you need, when you need them. Below is our 2024 new Frameworks workplan - please contact us if you would like to know any more about any of these.

#### Pensions Administration Software (current Framework expires April 2025\*)

Since its launch in 2020 this Framework has been hugely popular. It provides users with a quicker and easier route to procure complex LGPS administration software, and is supported by a comprehensive set of procurement documents. Due to the complexity of this Framework we are looking to start the procurement process early in 2024.

#### Actuarial, Benefits and Governance Consultancy Services (current Framework expires June 2025)

The original National LGPS Framework! This Framework continues to be as popular as ever and this will be its 4th iteration. We are looking to commence this procurement in Summer 2024 ahead of a launch in June 2025.

## Could you be a Founder?

Each National LGPS Framework is the result of a need identified within the LGPS and then a small number of Funds and Pools voluntarily working together as Founders to establish a Framework to meet the need. Without the support of Funds and Pools as Founders, the Frameworks wouldn't exist. The Founders are at the heart of every Framework; from shaping the specification of services through to evaluating the Provider responses. To date 49 Funds and Pools have acted as Founders, often multiple times and on more than one Framework!

Supported by the National LGPS Frameworks Team, Norfolk County Council Procurement and Legal Teams, Founder meetings are held to develop the specification and tender documents, quality questions, and pricing. Founders evaluate and moderate the tender responses before contracts are awarded.

It really helps to have a diverse group of Founders (including where appropriate Pools) to act as Founders to help ensure that new Frameworks meet the needs of the whole LGPS. **New Founders are always very welcome!**

## **Transition Management Framework?**

The previous Transition Framework closed at the end of 2022. As there was no clear demand then for a replacement, the Founders decided not to re-procure at that stage. More recently we have had a number of enquiries from potential users and conversations with LGPS colleagues who are keen to support the establishment of a new Transition Framework.

# Pensions Administration Software Framework—now updated to include Integrated Service Provider (ISP) Provision

This current Framework has been varied to include specific terms to allow for the provision of ISP services to be included within contracts awarded via this Framework.

Users who have already appointed their software provider via this Framework can also extend their existing contract to incorporate ISP provision.

If you would like further details on the variation please do get in contact with us.

NOTE: If you are looking to procure an ISP provision independently from your Pensions Admin Software contract, the new National LGPS Framework for ISP and Member Data Services will be available in April 2024.

## **Current National LGPS Frameworks**

There are currently seven live National LGPS Frameworks available to all LGPS Funds, Pools and Employers and the wider public sector nationally for the procurement of pensions related services from a range of specialist qualified providers. These are:

- Global Custody Services (expires February 2025\*)
- Pensions Administration Software (expires April 2025)
- Actuarial, Benefits and Governance Consultancy Services (expires June 2025)
- Stewardship Services Framework (expires March 2026)
- Pensions Administration Operational Support Services (expires April 2026)
- Investment Management Consultancy Services (expires October 2026)
- Legal Services (expires January 2027)

IMPORTANT: Please make sure you note the end dates of Frameworks when you plan and prepare for your call-off. If you are planning to use a Framework which expires soon, your Contract Award must be completed by the expiry date of the Framework (although contracts let under the Framework can be for longer periods).

\* we will be exploring the potential for a 1 year extension to the Global Custody Framework

Our office hours will be slightly different over the Christmas and New Year period.


The office will be closed from midday Friday 22nd December 2023 and will reopen again at 08:30am on Tuesday 2nd January 2024.
