

LGA Training Programme 2026

Our training programme includes training for employers, administrators, officers with governance responsibilities and pension committee and local pension board members. As requested, we will deliver training in a variety of formats.

We have two new courses available in 2026:

- Additional contributions a half day online course covering additional pension contributions (APCs) and additional voluntary contributions (AVCs)
- Understanding tax allowances in the LGPS a full day course available online and in person covering annual allowance, lump sum allowances and inheritance tax.

Course availability

If you are unable to secure a place on any of the training courses listed below, please let us know by emailing training.lgps@local.gov.uk. We will do our best to put on additional courses where possible. For administrator training, each topic is limited to five attendees per organisation to ensure fairness. If you have more than five attendees, you may wish to consider commissioning a training course.

Tutor led training

We limit our practitioner and employer training to a maximum of 18 attendees. This is to ensure that everyone has sufficient opportunity to interact with the trainer and other attendees. For this reason, and as a revenue protection measure, all online attendees are required to keep their cameras turned on for the duration of the training.

The cost of full day courses is £270 (plus VAT) per person for online training and £310 (plus VAT) for face-to-face training.

The cost of half day courses is £135 (plus VAT) per person. All half day courses are held online.
